Empanelment and Rate Contract for Emergency Shelter Kits (ESKs) – PAN India

1. About Habitat for Humanity India

We provide shelter assistance with shelter materials and tools to assist families in building temporary shelters or repairing homes and WASH facilities. These efforts support families in preparing and protecting themselves during adverse weather conditions such as monsoons.

Emergency shelter kits (ESK) are essential components of disaster relief efforts, designed to provide immediate shelter and basic living necessities to people displaced due to natural disasters, conflicts, or other emergencies. Emergency shelter kits are designed to save lives and to quickly provide temporary shelter solutions that can be easily transported, assembled, and adapted to various environments. An emergency shelter kit such as tarpaulins with basic tools such as ropes, and nails will enable repair homes and make them habitable. These kits are also crucial for maintaining human dignity and providing a sense of security and normalcy in the aftermath of a disaster.

2. Scope of Work

Supply and delivery of Emergency Shelter Kits (ESKs), as per region-specific specifications provided in Annexure 1, 2 and 3. The kits must conform to the technical standards and contents detailed therein.

3. Site Location

Delivery locations will span PAN India, with dispatch requirements differing by region as per project needs.

4. Payment Terms

- a) 30% advance upon acceptance of Purchase Order (PO) and signing of contract.
- b) 70% upon delivery and acceptance of goods at designated sites, supported by a Delivery Challan and Invoice.

5. Delivery Timeline

Delivery of ESKs must be completed within **7 to 10 working days** from the issuance of the PO, unless otherwise agreed upon in writing. Vendors must indicate their capacity to meet the delivery timeline per region.

6. Awarding of Contract

Habitat for Humanity India reserves the right to award the contract either to a single vendor or to multiple vendors, based on evaluation of bids, delivery capabilities, and project requirements. We may also split the order based on cost-efficiency and logistics.

7. Quotation Submission Guidelines

a) Submit your proposal by email with the subject line:

Note: No physical submissions will be accepted.

- b) Adherence to payment terms as per Section 4 is mandatory.
- c) Quotation validity must be **minimum 6 months** from the date of submission.
- d) Vendors not currently empaneled with HFH India must undergo HFH India's Due Diligence Review (DDR) process and agree to the organization's Safeguarding Policy.
- e) Prices must be submitted region-wise and slab-wise using the format provided in point 8 Price Submission Format. All prices must be inclusive of packaging, transportation, and applicable taxes.
