- b. **Rooftop Rainwater Harvesting System for 27 new houses (approx. 300 sq ft each)** in Sollepuradoddi, Ramanayakanadoddi, Annayanadoddi, Ragihalli Villages, Anekal Block, Bengaluru Urban, Karnataka, as per the approved designs and Bill of Quantities (BOQ).
- c. **Grey Water Reuse System for 27 new houses (approx. 300 sq ft each)** in Sollepuradoddi, Ramanayakanadoddi, Annayanadoddi, Ragihalli Villages, Anekal Block, Bengaluru Urban, Karnataka, as per the approved designs and Bill of Quantities (BOQ).

4. Payment Terms:

- a) FTR 1 = 20% - Foundation level - Site marking, Footing & stub column, Grade beam, plinth filling and DPC
- b) FTR 2 = 25% - Lintel level - Floor PCC, Brickwork till lintel level, lintel, loft and sunshade casting
- c) FTR 3 = 25% - Roof level - Brickwork till roof slab level, beam and slab casting
- d) FTR 4= 20% - Finishing and Services- Parapet, steps, Fixing MS grill, ventilators and door frame, kitchen slab, External, Internal and ceiling plaster, Terrace waterproofing and finishing, Complete Electrical and plumbing work (concealed) Leach pit, Rainwater harvesting and grey water system
- e) FTR 5= 10% - Finishing and handover - Flooring and tile work, External and internal Painting, Terrace heat reflective paint, fixing windows, and doors, fixing OHT and complete external plumbing and electrical works.
- f) A retention amount equivalent to 5% of the total contract value shall be deducted from the contractor's every installment/payment and retained for a period of six months from the date of formal handover of the project. The retained amount shall be released upon expiry of the said period, subject to satisfactory rectification of all defects, snags, repairs and deficiencies, if any, identified during the retention period.

Work should be completed and handed over by **28th February 2027**.
